C25.179 APOLOGIES FOR ABSENCE

Members received apologies for absence from Cllr. D. Ingram due to a personal commitment.

C25.180 CO-OPTION

Cllr. Bowen's report had been circulated. Cllr. Bowen highlighted several points in his report including the current state of the County Council's finances and the Council's proposal for Local Government Reorganisation, which was approved at the Council's meeting held on 6th November, for a single unitary authority.

C25.184 HEAD OF NATURAL, BUILT & HISTORIC ENVIRONMENT

Members discussed the implications of the Property Flood Resilience scheme with the Head of Natural, Built & Historic Environment (Malvern Hills District Council), who wished to assure the Town Council her commitment and support in finding solutions to planning, conservation and listed building considerations in any proposed flood resilience measures. The department is currently recruiting additional Heritage Officers and planning application times have been reduced. The District Council does not want to hold the scheme from progressing.

A Member queried if the planning application process could be started prior to funding being in place. The Officer stated that detailed applications would be required before a decision could be made.

C25.185 BURGAGE BOWLING LEAGUE

Members received a presentation from a member of The Burgage Bowling League and consider the club's requests.

The representative stated that the club is aware that the Council is facing difficult financial times, therefore the club would like to request that the Town Council consider assigning the upkeep of the bowling green to the club, which would be undertaken by themselves and/or contractors. The club believe this would cut the cost of the bowling green upkeep to the Council and reduce fees for the club members.

A Member stated that funding of the green maintenance is from Tenbury residents' Council Tax, could the club provide the number of club members who reside in Tenbury for Council Tax purposes.

The representative stated that he did not know the exact numbers and would forward the numbers to the Town Clerk.

Another Member asked if the bowling league would request exclusivity of the green if they were maintaining it.

The representative stated that the league would not ask for this and the general public would still be able to use the facility.

It was unanimously
