A report was received and circulated.

A representative of the team stated that the officers had been busy with community engagement, visiting businesses and attending local events, having scheduled visits from the community engagement van, conducting school visits and carrying out foot and bike patrols around town. The team are looking to introduce regular drop-in surgeries.

The officer highlighted that due to different circumstances the local team would be down on numbers of officers on active duty. The Police and Crime Commissioner suggested that the Town Council invite the local Sargeant and Inspector to a Council meeting to impress the necessity of filling the roles.

# (iv) Malvern Hills District Council

Cllr. Bruton and Cllr. Wilmott submitted reports, which had been circulated.

Cllr. Bruton stated that there is a planned drop-in support session for the 150 employees of Kerry's who are scheduled to be made redundant.



## C25.132 POLICE AND CRIME COMMISSIONER

Members received a presentation from the Police and Crime Commissioner, Mr John Campion. Mr Campion explained that Worcestershire and Herefordshire forces will work together in a bid to enhance services by removing boundaries. These changes should ensure that Tenbury benefits from an increase in the available officers.

Mr Campion stated that while all reported crimes are recorded, not all crimes are filtered to the local team, but he wishes to assure the public that action is taken on all reported crimes.

Mr Campion wished to stress that prevention is key and that there is a budget to provide educational events for issues such as vehicle crime, speeding and smart water.

A Member questioned with regards the reported £8 million shortfall in the policing budget, how it would affect the number of officers.

Mr Campion replied that the funding from Government has not kept pace with the wage increases, however it is a requirement to maintain officer numbers, so changes made include condensation of the incremental wage increases and cutbacks in civilian roles.

A Member asked whether the force could maintain sufficient new recruits.

Mr Campion replied that there are enough applications to fill every position several times over in West Mercia, however, due to funding, starting point salaries are not adequate to attract older, more experienced applicants.

A Member stated that the town is fortunate that crime numbers are relatively low, but that does not stop the elderly and vulnerable feeling frightened. Members are finding it difficult to choose three issues to highlight for the Police Contact Contract as it is felt that this is putting less importance on the other issues.

Mr Campion replied that all crimes are relevant, but it is important to have a framework of priority to work from. Mr Campion stated that the Neighbourhood Matters scheme is a great tool for giving and receiving information on what is occurring locally. However, any additional concerns may be raised with the Safer Neighbourhood Team.

A Member stated that she was surprised that the town did not receive all the crime statistics.

Mr Campion stated that the statistics are available, however, anything that could be identifiable is withheld.

A Member asked what the regulations were with regards dangerous dogs.

Mr Campion stated that this was a licensing issue.

The Chair thanked Mr Campion for his time.

The Police and Crime Commissioner and the three representatives of the Safer Neighbourhood Team left the meeting at 7.57 pm.

There now followed a change in the order of the agenda.
